Enervest Operating, LLC (Enervest) has requested to produce the above-referenced wells at unorthodox locations, described above in the caption of this letter. The proposed locations were approved as unorthodox gas well locations in the Blanco Mesaverde and Basin Dakota Pools in Order NSL-5397. By Order NSL-5397-A, these unorthodox locations were also approved in the Tapacito Gallup Associated Pool (58090).

By this application Enervest seeks to complete the Jicarilla A Well No. 8N in the Blanco Mesaverde Gas Pool (73219) and the Basin Dakota Gas Pool (71599) at an unorthodox bottom hole location 1432 feet from the South line and 2563 feet from East line (Unit J) of Section 17. This location is unorthodox in both said pools under applicable special pool rules.

Your application has been duly filed under the provisions of Division Rules 15.13 [19.15.15.13 NMAC] and 4.12.A(2) [19.15.4.12.A(2) NMAC].

It is our understanding that you are seeking these locations in order to conform the Division's approval to the actual bottom hole location of the Jicarilla A Well No. 8N, as drilled.

It is also understood that notice of this application to offsetting operators or owners is unnecessary due to common ownership.

Pursuant to the authority conferred by Division Rule 15.13.B, the above-described unorthodox locations are hereby approved.

This approval is subject to your being in compliance with all other applicable Division rules, including, but not limited to Division Rule 5.9 [19.15.5.9 NMAC].

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
