Energen Resources Corporation is the operator of a 320.00 acre spacing unit in the Basin Fruitland Coal Pool **(Pool Code 71629)** comprised of the East-half of Section 21, Township 32 North, Range 5 West, N.M.P.M., Rio Arriba County, New Mexico. This spacing unit is dedicated to Energen's Carracas 21 A # 15 which was drilled and is capable of production from the Fruitland Coal formation.

Energen seeks administrative approval of the simultaneous dedication of this 320.00 acre spacing unit to the following two gas wells:

A. the **Carracas 21 A # 15 well (API No. 30-039-24424)** vertically drilled from a surface location 790' FSL and 1,850' FEL of Section 21. This well was temporarily abandoned when the Carracas 21 A # 1H was drilled and \bigcirc


