Describe Cause of Problem and Remedial Action Taken.*

The gas line from the battery header to the main line developed a quarter size hole. Upon discovery of leak, valves were located to isolate section of gas line and affected wells were shut in.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 10' X 50' (pipeline right of way). A contractor was called in to find the hole in the gas line and to fix the line. As impacted soils are being dug out, they are being put on a plastic liner and samples will be taken from the stockpile to determine if the soils are suitable to re-use as backfill for the excavation. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (260', Section 9, T19S-R25E, NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 0.**
