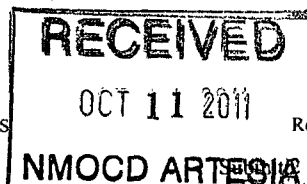


Describe Cause of Problem and Remedial Action Taken.*

The equalizer valve was closed causing the oil tank to overflow. The equalizer line has been opened and there will be closer inspection of equalizer valves in the future.

Describe Area Affected and Cleanup Action Taken.*

Initially 60bbls of oil were released from the oil tank and we were able to recover 50bbls with a vacuum truck. The entire release was completely contained inside the facility walls of the tank battery. All free fluid has been recovered and the tank has been steam cleaned. Contaminated soil inside the facility has been removed and sent to disposal. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD/BLM for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. Gentlemen,

Please see below the detailed description for a release that occurred on 09/26/2011.

On 9-26-11 at 7:00 a.m. an oil tank at the Electra North battery was found running over. The spill was caused by equalizer valves being closed and sealed on adjacent tanks. The equalizer valves were opened and the battery returned to normal operations. 60bbls of oil was released into the unlined dike. 50bbls of oil were recovered. A vacuum truck picked-up all standing fluids, contaminated gravel was hauled to CRI. The tank was steam cleaned, then all cleaning fluids picked-up and disposed. Remediation within the dike upon HSE approval.
