Dear Mr. Hudson:

The New Mexico Oil Conservation Division (OCD) has reviewed the initial investigation report (dated October 21, 2011) for the above-referenced site. Since the report indicates that there was no chloride release at the boring locations, the OCD is not requiring vadose zone remediation at these locations. However, the OCD still maintains that the chloride discovered in the groundwater at the site could be related to activities conducted by Chevron at or near the site in the past. Therefore, the OCD is requiring Chevron to monitor on an annual basis for chloride and TDS in the groundwater at the site. The Rice Operating Company's existing groundwater monitoring wells, MW-3 and MW-1 would be acceptable monitoring locations.

Chevron must report on an annual basis to the OCD the results of the groundwater monitoring at the site. The first report will be due on April 1, 2013, for the chloride and TDS monitoring conducted in 2012.

Edward,

I've reviewed the Rice report and historical data, as well as the operational history of our tank battery. I did not find any record of a historical release associated with the tank battery that would have resulted in the elevated chloride concentrations reported by Rice. However, Chevron proposes to conduct a soil investigation around the tank battery, upgradient of Rice's monitoring well MW-3, to assess whether there is evidence of a release from the battery. This would consist of 4 to 6 soil borings to a depth of approximately 20 feet. We will collect samples at 5-ft intervals and analyze for chlorides and TDS. We will report the results to NMOCD, along with recommendations for further activities, if warranted.

Please let me know if NMOCD agrees with this approach.
