Chesapeake Operating, Inc. ("Chesapeake") hereby seeks administrative approval pursuant to the provisions of Division Rules 19.15.15.13 and 19.15.16.14 for an unorthodox well location for its Crow Flats 14 16 28 USA Well No. 2H. This well is located in Section 14, Township 16 South, Range 28 East, N.M.P.M., Eddy County, New Mexico and is to be drilled in the Wolfcamp formation at a surface location and a penetration point 1980 feet from the North line and 10 feet from the West line and a bottomhole location 1980 feet from the North line and 350 feet from the East line of Section 14, Eddy County, New Mexico. A 160-acre project area has been dedicated to this horizontal well comprised of the S/2 N/2 of Section 14.

This location is unorthodox because the Wolfcamp (oil) formation under this acreage is governed by the Division's statewide rules which provide for wells on 40-acre spacing units to be located no closer than 330 feet to the outer boundary of the spacing unit. Division Rule 19.15.16.14 defines the "Penetration Point" as "the point where the wellbore penetrates the top of the pool from which it is intended to produce." The wellbore penetrates the Wolfcamp formation at a point 10 feet from the West line of Section 14 and is therefore closer than allowed by Division rules.

Although the wellbore penetrates the top of the Wolfcamp at an unorthodox location, Chesapeake will case and cement the wellbore and will not perforate the well until it reaches a standard location within the producing area.




