Reference is made to your application received on October 28, 2011.

You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary, and Rule 15.16.14.B(2) [19.15.16.14.B(2) NMAC] concerning directional wells in designated project areas. This location is unorthodox because portions of the proposed producing interval are less than 330 feet from an outer boundary of the project area. A portion of the "producing interval" as defined in 19.15.16.7.H NMAC is outside the project area. However, you have specifically represented that the completed interval (portion of the wellbore open to the formation) of this well will be entirely within the above-described project area.
