The New Mexico Oil Conservation Division District 2 Office (OCD) is in receipt of a document titled "Soil Assessment and Remediation Work Plan", and dated November 3, 2011 (plan). The plan was formulated and submitted to OCD by Lime Rock Resources' agent, Talon, LPE. The plan proposes methods to be used in remediation of soils impacted as a result of the above referenced produced fluid release. The plan is approved with the following conditions/stipulations:

- Notify OCD District 2 Office 48 hours prior to commencement of remedial activities.
- Notify OCD District 2 Office 48 hours prior to obtaining samples where the analyses will be submitted to OCD.
- Notify OCD District 2 Office 48 hours prior to installing liner.
- No portion of the liner may be closer than 4' to surrounding natural surface grade.
- OCD may modify these conditions of approval at any time during the project as site conditions may warrant.
- Submit a Form C-141 Final Report, and, closure report, upon satisfactory completion of project.
- Project is to be completed and closure documentation submitted to OCD not later than January 30, 2012.
- Like approval by any other regulatory authority as may be applicable.

Be advised, OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
