Dear Mr. Johnson:

Thank you for your letter of July 19, 1985 calling my attention to the request to release the bond on our geothermal well #25-34 at Radium Springs, Dona Ana County. Your records are correct that the well has not been plugged and abandoned. The request to release the bond was an apparent misunderstanding within Hunt and between Hunt and our bonding agent. The bond will remain in force.

Well 25-34 is still shut in. As you may remember, Hunt had proposed a development project for the prospect. This proposal failed to materialize because El Paso Electric Co. was not interested in negotiating an agreement with us. Hunt still hopes to develop the prospect and use well 25-34 as a production well, but we cannot proceed until we find a legitimate buyer for the heat and/or electricity. The well will remain shut in until then. As soon as we reach an agreement with a buyer, we will submit the appropriate applications for permits.

While I am unable to set a definite time frame to our program, I would be happy to update you on our progress at any time. Please write or call me at 214/880-8420.
