R.T. Hicks Consultants, Ltd. is pleased to submit this 2010 Annual Ground Water Monitoring Report for the B-29 site located in the BD Salt Water Disposal System (SWD). This report contains:

- 1. A table presenting all laboratory results and depth to ground water for each well at the site.
- 2. Graphs showing the concentration of chloride and TDS in ground water over time.
- 3. A figure presenting the location of the monitoring wells and the most recent ground water sampling results.
