Dear Mr. Conder:

The New Mexico Oil Conservation Division (OCD) has received the Rice Operating Company's (ROC) Soil Closure Request for the Abatement Plan (AP-58) for the BD Santa Rita EOL Release Site, dated October 10, 2012. The above-referenced report, submitted in partial fulfillment of 19.15.30.19 NMAC (Part 30.19, formally, Rule 19.K), indicates that ROC has partially met the requirements of 19.15.30.9 NMAC for this site. Therefore, the OCD hereby conditionally approves the Soil Closure Request for the BD Santa Rita EOL Release Site and no further soil remediation is required for this site:

The ROC BD Santa Rita EOL Release Site is still active under Abatement Plan, AP-58, and groundwater monitoring, further groundwater contamination delineation if warranted, and groundwater remediation must continue at the ROC BD Santa Rita EOL Release Site.

ROC must re-vegetate the groundwater recovery facility portion of the ROC BD Santa Rita EOL Release Site when the groundwater recovery facility is dismantled.

Please be advised that OCD approval of this request does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the owner/operator of responsibility for compliance with any OCD, federal, state, or local laws and/or regulations.
