

Arrived and shut in line and started looking for leak. Leak was located at a field valve and was on main trunk line. All wells on line were shut in and vacuum truck was called to pick up spill.

Describe Area Affected and Cleanup Action Taken.\*: Approximately 10 bbls were picked up. Vacuum truck also tied on to line and drained to prevent more spilling as line drained.
