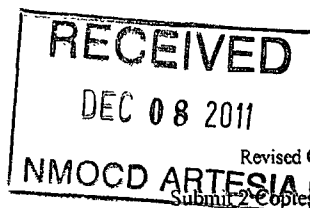

Describe Cause of Problem and Remedial Action Taken.*


A 1/2 inch pipe on the lact unit broke causing crude oil to leak onto the ground. Upon discovery, the valves on the back of the unloading tanks were shut off, stopping the flow of oil to the lact.

Describe Area Affected and Cleanup Action Taken.*

On the site pad, an area of approximately 6' x 20' Off the pad, into the pasture, an area approximately 30' x 80'. Being misinformed that this was state land I immediately made notification via voice mail, to the New Mexico Oil Conservation District in Artesia, NM. JWS out of Riverside, NM responded with a vacuum truck and recovered approximately 5 bbls. of crude from the ground. Hungry Horse Environmental Services out of Hobbs, NM, responded for clean up. Excavation began off the site pad due to the ground being sand and believing the oil would soak in faster. On 12-05-11 excavation work off the site pad was stopped after speaking to Terry Gregston with BLM, until such time a BLM representative can inspect the site. The contaminated soil that was removed prior to speaking to BLM was taken to CRI in Hobbs, NM for disposal storage
