Re: Application to add 25 wells
Dugan Productions
Turk's Toast Gas Gathering System
San Juan County, New Mexico

Dear Ms. Bailey, Mr. Evans & Mr. Roybal,

We are writing to request your administrative approvals to add 25 wells to Dugan Production's existing Turk's Toast Gas Gathering System (TTGS), which will require the surface commingling of gas plus off-lease measurement and sale of produced natural gas. The TTGS was last approved by the BLM on 2-20-04, the NMOCD on 8-28-01 (PLC-187), and the NMSLO on 1-27-04, and currently has 43 wells (48 completions) approved for operation on the TTGS. The 25 wells to be added include 20 completions operated by Dugan Production in the Basin Fruitland Coal Gas Pool (71629), two completions in the Harper Hill Fruitland Sand gas pool (78160), one completion in the Twin Mounds Fruitland Sand Pictured Cliffs gas pool (86620) and one completion in the Greek Gallup oil pool (96219), plus three wells to be operated by Encana Oil & Gas (USA) Inc., each of which will be completed as horizontal completions in the Greek Gallup oil pool (96219). Production from each of these four pools is currently authorized for operation on the TTGS in one or more of the 48 completions currently authorized for the TTGS. Of the 25 wells being added, three are located upon state leases E-3555, E-6714 and LG-3045; 17 are on federal leases NM-4465, NM-10561, NM-10875, NM-16057, NM-16765, NM-70298, NM-70299, NM-113433, NM-113973; and 5 are on fee leases. There is no Indian acreage associated with any of the wells to be added. The 3 wells to be operated by Encana Oil & Gas (USA) Inc. are located upon leases currently held by Dugan Production and will be jointly owned by Dugan Production and Encana Oil & Gas. Encana has requested and Dugan Production has agreed to add their 3 wells to the TTGS. **Attachment No. 8** presents a copy of the Participation Statement by Encana Oil & Gas (USA) Inc. to include the gas production from these 3 wells in Dugan's TTGS. Gas produced from Encana's wells will be treated the same as the gas produced from all other wells, i.e., it will be measured by Dugan Production prior to entering the TTGS and the allocation procedures used for all other wells will be used. This addition should have little to no effect upon the interest of any well currently operating on the TTGS. Should production from Encana's wells exceed the available capacity of the TTGS, we will consider other options to facilitate gas sales from Encana's wells.

Dugan Production's TTGS currently has 63 completions connected and during March, 2012 production from all wells averaged 1823 mcf/d plus 9.5 bbl of oil and condensate per day. Production comes from 4 gas pools and 4 oil pools. Production statistics for each pool and the CDP gas sales are presented on

Attachment No. 4. The 63 active completions includes 59 gas pool completions that average 30 mcf/d per well (ranging from 19 to 126 mcf/d per well), and 4 oil pool completions that average 1.7 BOPD + 7.6 mcf/d per well (the largest well producing 5.7 BOPD + 19.3 mcf/d gas). Thus, for the most part, all wells currently connected to the TTGS are considered to be low volume, marginal producing wells. The central delivery gas sales meter (CDP) for the TTGS is located in the SENE of Section 6, T-29N, R-14W and delivers gas to Enterprise Field Services at their Meter No. 14102.

The TTGS was initially authorized in September of 1988 and this application will be the 5th expansion. NMOCD Form C-107B is attached in support of this application. **Attachment No. 1** presents the 25 wells (27 completions) being proposed for addition to the TTGS. Of the 25 wells, 12 (listed as application status B) were included in an application dated 11-19-03 which was approved by the BLM on 2-20-04 and the NMSLO on 1-27-04, however we did not receive NMOCD approval for adding these 12 wells and are now including these 12 wells along with the 13 new wells being proposed for the TTGS. Our failure to receive NMOCD approval for the 11-19-03 application appears to be more a result of our letting the application get lost in our efforts to gather and sell coalbed methane (CBM) gas from the underground mining operations of San Juan Coal. Our 11-19-03 application did include our proposal to add CBM gas from San Juan Coal to the TTGS, however there were many issues to resolve and we have since terminated our efforts to add CBM gas from San Juan Coal to the TTGS.

Attachment No. 2 presents well, lease and production information for each of the 25 wells (27 completions) being added plus the 43 wells (48 completions) currently approved for the TTGS.

Attachment No. 3 presents a map of the TTGS. In addition, Dugan Production's leasehold interest is also presented which includes 22 federal leases, three state leases, plus nine fee leases. Dugan Production is the operator of all wells except the Kelly No. 1 which was initially operated by Redwolf Production Inc. and was plugged and abandoned by the Kelly Family Land Co. on 12-2-08. As presented above, 3 of the wells proposed for addition will be operated by Encana Oil & Gas (USA) Inc. which will be located upon leases currently held by Dugan Production. These wells and associated leases are also presented on Attachment No. 3. There are two types of gathering lines presented on Attachment No. 3. The solid line primarily represents connections to the wells typically producing little to no water. The dashed lines represent the gathering system installed to primarily gather gas and water (in separate pipelines) from completions in the Fruitland Coal and Pictured Cliffs. Typically these wells produce large volumes of water and the gathering system includes a separate pipeline for the water which is collected at the Turk's Toast No. 4 well for disposal into the Mesaverde formation (SWD-851). The natural gas from some of the Fruitland Coal wells in this area does contain hydrogen sulfide and is kept separate from the gas produced from the other wells until treating for H₂S removal. The gas from the Fruitland Coal wells is collected at the Monte Carlo No. 2 well site. This gas is treated for H₂S removal and then placed into the main gathering system line for sale. Any volume shrinkage associated with the H₂S removal will be credited only to the wells producing H₂S.

We do not anticipate commingling oil or condensate. Each well producing oil or condensate will be equipped with separation equipment and all oil or condensate will be separated, stored, and sold on the lease. Each well will be equipped with a continuous recording gas allocation meter (or some form of approved alternative measurement) operated and maintained by Dugan. Prior to converting any gas measurement from a conventional allocation meter to an alternative measurement method, we will seek formal approvals. The charts from each allocation meter are integrated monthly by a commercial integration service and the volumes recorded utilized to determine factors for allocating CDP volumes, BTU's and revenues to the individual wells. The allocation procedures are presented on **Attachment No. 7** and will also be used for the wells to be added.


Attachment No. 5 presents a summary of the interest owners in the wells currently connected and the proposed additions to the TTGS. In addition to Dugan Production, there are three other working interest owners, three types of royalty interest (state, federal and fee), plus 41 overriding royalty interest owners. As required by OCD Rules, all interest owners in the wells currently approved plus the wells proposed to be added to the gathering system have been given notice of this application. **Attachment No. 6** includes a copy of the letter sent to the working interest owners. Complete copies of the application are also being

sent to the State Land Office (for state royalty), and Bureau of Land Management (for federal royalty) requesting their approvals. In addition, all fee royalty interest owners and all overriding royalty interest (ORRI) owners were provided with a detailed description of this application and were offered a complete copy of the application should they desire a copy. A copy of the notice letter sent to the fee royalty and ORRI owners is included in Attachment No. 6. All notice letters have been sent by certified, return receipt mail and upon receiving the receipts, copies will be forwarded to the NMOCD. Also included in Attachment No. 6 is a copy of the legal notice which is scheduled to be published in The Farmington Daily Times on June 17th, 2012 to further provide notice to all interest owners, anticipating that out of the 74 notices mailed, there will invariably be some receipts not returned. As provided by Rule 19.15.12.10C(4)(g)(i&ii), Dugan Production is requesting that the NMOCD Order issued for this application also include a provision that for future additions to the gathering system, only the interest owners in the wells being added need to be notified, provided that in reasonable probability the proposed additions will not adversely affect the interest owners in the wells already approved for the system. Our letters to each of the interest owners did include a notice of this request. This provision will be very helpful and will greatly reduce the work effort necessary to add wells to the TTGS.

In summary, Dugan Production Corp. is requesting approval to add 25 wells (27 completions) to the TTGS which will require surface commingling plus off-lease measurement and sale of produced gas. The wells and gas added will be operated in the same manner that has previously been authorized by the BLM, NMOCD and the State Land Office for the 43 wells currently approved for the operation on the gathering system. Included in the 25 wells are three proposed horizontal oil wells to be operated by Encana Oil & Gas (USA), Inc. In addition, we are requesting the NMOCD to amend the interest owner notice requirements such that only the interest owners in the wells being added are required to receive notice of our application.

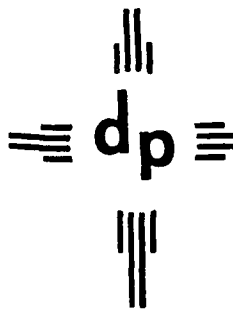

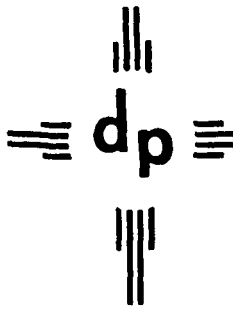

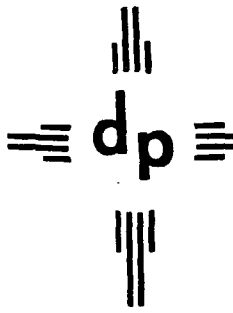

Dugan Production's current company-wide gathering system fee is \$0.27/MMBTU, and our compression fee is \$0.09/MMBTU. These fees will be used until operating economics indicate the need for revisions.

This proposal should not affect your interest in these wells and should allow for optimum operations on all wells, especially the Fruitland Coal wells. All wells will benefit from central compression which should keep wellhead operating pressures as low as possible. This method of operation will help to keep our operating expenses as low as possible, which will allow all interest owners to recover more of the gas reserves from each well.

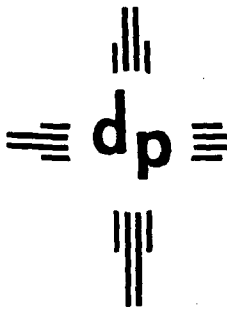

COPY OF PUBLICATION

Dugan Production Corp. is applying to the New Mexico Oil Conservation Division (NMOCD), the Bureau of Land Management (BLM) and the New Mexico State Land Office (NMSLO), for regulatory approvals to add 22 existing wells all operated by Dugan Production, plus 3 proposed wells to be drilled and operated by Encana Oil & Gas (USA) Inc., to Dugan Production Corp.'s Turk's Toast Gas Gathering System. This will require the surface commingling of natural gas and produced water plus the off-lease measurement and sale of natural gas. There will not be any commingling of oil or condensate. Dugan Production is also requesting that the NMOCD amend the existing surface commingling order to allow future additions to the gathering system following notice only to the interest owners being added, provided it is reasonably certain that the proposed additions will not affect the wells previously authorized for the gathering system.
