Mike,

Talon/LPE is sending the analytical results for the soil samples collected at the Devon Energy Corp. Hackberry 18 Fed. No.1 release. Terry Gregston has instructed Devon Energy Corp. to start excavating the hydrocarbon impacted soil located behind the tank battery to 1'-feet bgs. Terry also had Talon excavate the frac fluid impacted soil located west of the location to 1-foot bgs.

The hydrocarbon impacted soil located with-in the bermed area of the tank battery was excavated to 1-foot bgs. All soil excavated was loaded directly into haul truck and transported to CRI for disposal.

You were notified to witness when soil samples were collected from the excavated area located on Enterprises right-of-way. On 4/11/2012 Talon/LPE collected soil samples for analytical from the excavated area located in the Enterprises Products right-of-way. The right-of-way was excavated to 2'bgs. There is a two track road running across the right-of-way which is currently blocked off. When Talon receives the analytical results I will forward the report to you. On 4/18/2012 Talon will start excavating and hauling the impacted soil from the frac fluids, which is located on the location. When the impacted soil has been removed from the location to .5-feet bgs, soil samples will be collected for analytical from the excavated area located behind the tank battery, the excavated area located west of the location and the excavated area on location. NMOC and the BLM will be notified to witness the soil samples collected. Talon/LPE is currently constructing a combined work plan and closure report for the Hackberry 18 Fed. No. 1 release.
