Dear Ms. Gregston,

Due to heavy rain in the area, the remediation actions at the Hackberry 18 Federal No.1 has been temporally suspended. On 5/16/2012 Talon/LPE will resume the remediation actions. Based upon the analytical results dated 04/30/2012, additional excavation actions will be taken at the soil sampling locations labeled S-24, S-29 and S-44. Soil samples will then be collected for confirmation after the excavation is completed.

On 5/11/2012 Talon/LPE meet with Roger Hernandez at the Hackberry 18 Federal No.1 location. Roger guided me to other Devon Energy Corporation locations in the area that need to be downsized. Devon Energy Corporation is requesting approval to use the material from the downsized locations for constructing a soil lift over the 20 Mi. liner which is to be placed over the drilling pit area at the Hackberry 18 Federal No.1? Devon Energy Corporation is requesting approval to use the material from downsized locations for backfilling the excavated areas located at the Hackberry 18 Federal No.1 location? If further information is required please contact me.

Question: has the BLM approved the work plan which was submitted for the remediation at the Hackberry 18 Federal No.1 release?
