THIRD AMENDMENT TO INACTIVE WELL AGREED COMPLIANCE ORDER

Pursuant to Ordering Paragraph 1.E of Inactive Well Agreed Compliance Order 235, the Director of the Oil Conservation Division (OCD), by and through her Compliance and Enforcement Manager, hereby amends Order 235 as follows:

FINDINGS

- 1. Yates Petroleum Corporation ("Yates") has submitted a timely and complete report to the OCD's Compliance and Enforcement Manager, and has plugged 53 wells and is in the process of evaluating the wells identified on Exhibit A of Inactive Wells Agreed Compliance Order 235 Amendment C (ACOI 235-C).
- 2. ACOI 235 provides that if Yates begins recompletion work or plugging operations on at least 7 of the wells by September 1, 2012, verified by the Compliance and Enforcement Manager's review of Yates's report, the OCD shall issue a third amendment to ACOI 235.
- 3. Yates filed a timely and complete report, verified by OCD that the following wells have either been re-completed or are in the process of recompletion:

ORDER

- 1. Yates shall submit a written report to the OCD's Compliance and Enforcement Manager, by March 1, 2013, describing the results of its evaluation of the remaining wells, and proposing a plan for returning those wells to compliance, with a timeline for achieving compliance.
- 2. The OCD shall remove the wells identified on Exhibit A of ACOI 235 until April 1, 2013.
- 3. The terms of ACOI 235 as amended by ACOI 235-C otherwise remain in effect and are extended through March 1, 2013.
