Thank You Mr. Hansen,

We would like to receive permission to place up to 1 gallon of 3% pharmacy grade hydrogen peroxide H2O2 every month, until we can meet the groundwater standard for organic constituents.
We will include all additions and results in our annual report next year.

In addition, we would like to fill the well bore with DI water and perform a level drop off test to determine the estimated permeability of the cavern. Once the test is complete, we will bail all excess water down to about one foot above the perfs. While diluting the sample somewhat, this will allow us to collect water samples including air samples.
