The commingled production shall be measured and sold at the Central Tank Battery located in Unit G of Section 12, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico. Oil and gas production from the wells is approved for off lease measurement and sales.

Oil and gas production from the wells shall be allocated on the basis of monthly periodic well tests, while total production from all the wells commingled at the Central Tank Battery shall be metered prior to being sold. This meter shall be calibrated semi-annually.

The producer/operator shall notify the transporter of this commingling authority.

The operator shall notify the Hobbs district office of the Division upon commencement of commingling operations.

The provisions of Order No. PLC-13 and its amendment shall remain in full force and effect.
