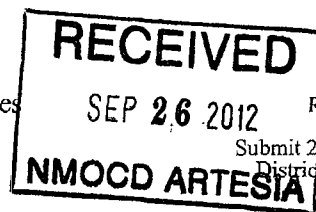

The valve on a 1" steel suction line between the triplex pump and tank was left open which caused 80 bbls of water to spill onto the ground. 0 bbls of water were recovered. The valve was closed to prevent further leaking.

Describe Area Affected and Cleanup Action Taken.\*

The area affected by the 80 bbls leak is approximately 40' x 100'. Remediation will be performed in accordance with an OCD and BLM approved remediation plan.
