Mack Energy Corporation as operator of the aforementioned well respectfully requests administrative approval for downhole commingling and measurement of production.

Mack Energy proposes to commingle Maljamar; Grayburg-San Andres and Corbin Delaware production in the Federal MA A #2, API 30-025-36388(Lease NM-016796). Production of both pools will be measured at the Federal MA A Tank Battery. This lease has common interest in both pools. The Federal MA A #2 decline for Delaware production has leveled off at 6-Oil and 18-Gas per day. Based on this information we will allocate production according to increased production from GB/SA allowing a 1% decline per month for Delaware production. Mack Energy has made notification to all parties owning an interest in this lease, including the oil purchaser, of the intent to commingle.

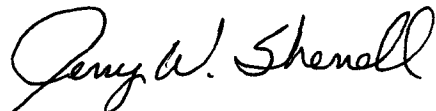
