Pursuant to Division Rules 104.D(2) and 104.C(2), Mewbourne Oil Company ("Mewbourne") applies for administrative approval of a non-standard gas spacing and proration unit, and simultaneous dedication, for the following infill gas well:

Empire "7" Fed. Well No. 1
660 feet FSL & 1650 feet FWL
Lots 3, 4, E $\frac{1}{2}$ SW $\frac{1}{4}$, and SE $\frac{1}{4}$ (S $\frac{1}{2}$ equivalent) of Section 7,
Township 17 South, Range 29 East, NMPM (292.96 acres)
Eddy County, New Mexico

The well will be drilled to test the Morrow formation, at an approximate depth of 10,800 feet. The well is within the South Empire-Morrow Gas Pool, which is spaced on 320 acres.

Attached as Exhibit A is a land plat of Section 7. The non-standard unit is necessitated by a variation in the government survey. The S $\frac{1}{2}$ of Section 7 is comprised of a single federal lease.

The unit is currently dedicated to Aspen Oil, Inc.'s Green B Fed. Well No. 11, located in the SE $\frac{1}{4}$ of Section 7, which produces from the Morrow formation. Mewbourne's proposed well will be an infill well under Rule 104.C(2). Pursuant to the rule, Mewbourne will be designated operator of both wells. Mewbourne is obtaining a Form C-104, changing the operator of the Green B Fed. Well No. 11 from Aspen Oil, Inc. to Mewbourne.


