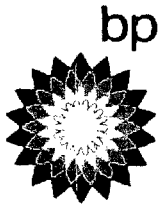

BP America Production Company respectfully requests an administrative approval for a non-standard well location for the Usselman Gas Com C Well No. 1 to be recompleted into the Basin Fruitland Coal Pool. The subject well was drilled in 1978 at a non-standard well location for the Blanco Pictured Cliffs Pool: Administrative Order NSL – 904, dated December 6, 1977 (copy attached for your reference).

The spacing unit for this well is the N/2 Section 04 as shown on attached C-102. Also attached is a 9 section plats with the subject well and surrounding wells and operators identified. Burlington Resources and Energen Resources are the affected offset operators. BP also operates offsetting tracts with minor differences in working interest ownership – all are being notified via certified mail on May 17, 2005.
