The above-named company is hereby authorized to surface commingle Northwest Hobbs-Tubb (Oil - 97211), Northwest Hobbs-Abo (Oil - 97212) and Northwest Hobbs-Drinkard (Oil - 97184) Pool production from the following-described fee leases located in Lea County, New Mexico:

Lease: B. Hardin Lease  
Description: NW/4 of Section 19, Township 18 South, Range 38 East, NMPM;

Well: B. Hardin Well No. 1 (API No. 30-025-36934)  
410' FNL & 348' FWL (Unit D) Section 19;

Lease: Lizzie Rice Lease  
Description: SE/4 of Section 13, Township 18 South, Range 37 East, NMPM;

Wells: Hobbs Deep "A" Well No. 1 (API No. 30-025-36046)  
Surface Location: 990' FSL & 660' FEL (Unit P) Section 13  
Bottomhole Location: 330' FSL & 660' FEL (Unit P) Section 13

Due to the diverse ownership between the B. Hardin and Lizzie Rice Leases, and in accordance with the provisions of Division Rule No. 303(B)(4)(a), production from each of the wells/leases shall be separately metered prior to commingling.

Production shall be stored at a central tank battery located in the SE/4 of Section 13, Township 18 South, Range 37 East, NMPM, Lea County, New Mexico.

NOTE: This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations. It is the responsibility of the producer to notify the transporter of this commingling authority.


The operator shall notify the Hobbs district office of the Division prior to implementation of commingling operations.
