
Production from each of the wells/leases shall be determined on the basis of well tests to be conducted at least on a quarterly basis.

Production shall be stored at a central tank battery facility at the Harris State Lease located in Section 23, Township 10 South, Range 32 East, NMPM, Lea County, New Mexico.

NOTE: This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Hobbs district office of the Division prior to implementation of commingling operations.
