Dear Mr. Wood:

Reference is made to the following: (i) your application on behalf of the operator, XTO Energy, Inc. ("XTO"), submitted to the New Mexico Oil Conservation Division ("Division") in Santa Fe, New Mexico on June 7, 2005; and (ii) the Division's records in Aztec and Santa Fe, including the file on Division Administrative Order NSL-5161: all concerning XTO's request to amend an existing order of the Division approving an unorthodox replacement Pictured Cliffs gas well location by expanding the vertical limits of the provisions in this order to include the Mancos formation.

Your application (*assigned NMOCD administrative application reference No. pMES0-518731819*) to amend Division Administrative Order NSL-5161 has been duly filed under the provisions of Division Rule 104.F.

By Division Administrative Order NSL-5161 (*administrative application reference No. pMES0-501859833*), dated March 6, 2005, XTO received authorization for its proposed Florance Well No. 24 (*API No. 30-045-32607*) to be drilled within a standard 160-acre gas spacing and proration unit in the South Blanco-Pictured Cliffs Pool (72439) comprising the SE/4 of Section 19, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico, at an unorthodox gas well location 2250 feet from the South line and 790 feet from the East line (Unit I) of Section 19.

The SE/4 of Section 19, being a standard 160-acre gas spacing unit pursuant to Division Rule 104.C (3) for the WC Basin Mancos (97232), is to be dedicated to this well.

By the authority granted me under the provisions of Division Rule 104.F (2), the above-described unorthodox Mancos gas well location for XTO's proposed Florance Well No. 24 is hereby approved.


Further all provisions of Division Order NSL-5161 dated March 6, 2005 shall remain in full force and affect until further notice.

Dear Mr. Wood:

Reference is made to the following: (i) your application on behalf of the operator, XTO Energy, Inc. ("XTO"), submitted to the New Mexico Oil Conservation Division ("Division") on January 18, 2005 (*administrative application reference No. pMES0-501859833*); and (ii) the Division's records in Aztec and Santa Fe: all concerning XTO's request for a replacement Pictured Cliffs gas well within a former standard 160-acre gas spacing unit in the South Blanco-Pictured Cliffs Pool (72439) comprising the SE/4 of Section 19, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico.

Your application has been duly filed under the provisions of: (i) Division Rule 104.F, revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999; (ii) Division Rule 605; and (iii) the "*Special Rules and Regulations for the South Blanco-Pictured Cliffs Pool*", as promulgated by Division Order No. R-10987, issued in Case No. 11705 on May 7, 1998.

From the Division's records, initial development of South Blanco-Pictured Cliffs gas production within this 160-acre unit commenced in 1956 when El Paso Natural Gas Company drilled and completed the Florance "D-LS" Well No. 7 (API No. 30-045-06313), located at a standard gas well location 900 feet from the South line and 1850 feet from the East line (Unit O) of Section 19. Last reported production from this well was in October, 2000. This well was plugged and abandoned by XTO in August, 2004.

It is further understood the E/2 of Sections 19 comprises a single Federal lease (*United States Government lease No. NM-03380*) in which XTO is the leasehold operator.


