Dugan Production hereby requests approval for an unorthodox location for the referenced well. Attached for your reference are the following exhibits:

1. Well location and acreage dedication plat (NMOCD Form C-102)
2. Topographic map
3. Offsetting Fruitland Sand Pictured Cliffs Working Interest Owners Map.
4. Offsetting Fruitland Sand Pictured Cliffs Royalty Owners Map.

The unorthodox location is necessary due to topographic conditions.

The subject well is located inside the Farmington city limits. Existing, commercial and industrial developments occupy all favorable topographic and orthodox areas within the proration unit.

On May 12, 2003 the New Mexico Oil Conservation Commission approved Dugan Production Corp.'s application (**administrative application reference No. pKRVO-309853720**) for a non standard location for the subject well with **Administrative Order NSL-4880**. The E/2 equivalent of irregular Section 12 was dedicated to the well in order to form a standard 320-acre more or less, stand-up gas spacing unit for the Basin Fruitland Coal pool.


In March, 2005 the subject well was drilled, production casing was set and cased-hole logs were run. Completion of this well will be carried out upon approval of this application.

Approval of this application would enable Dugan Production Corp. to develop both the Harper Hill Fruitland Sand Pictured Cliffs Pool (78160) and the Basin Fruitland Coal Pool (71629) in the same well-bore.

By certified mail, a copy of this application and request for administrative approval has been sent to all Fruitland Sand Pictured Cliffs offsetting operators and royalty interest owners, the Bureau of Land Management and the City of Farmington.



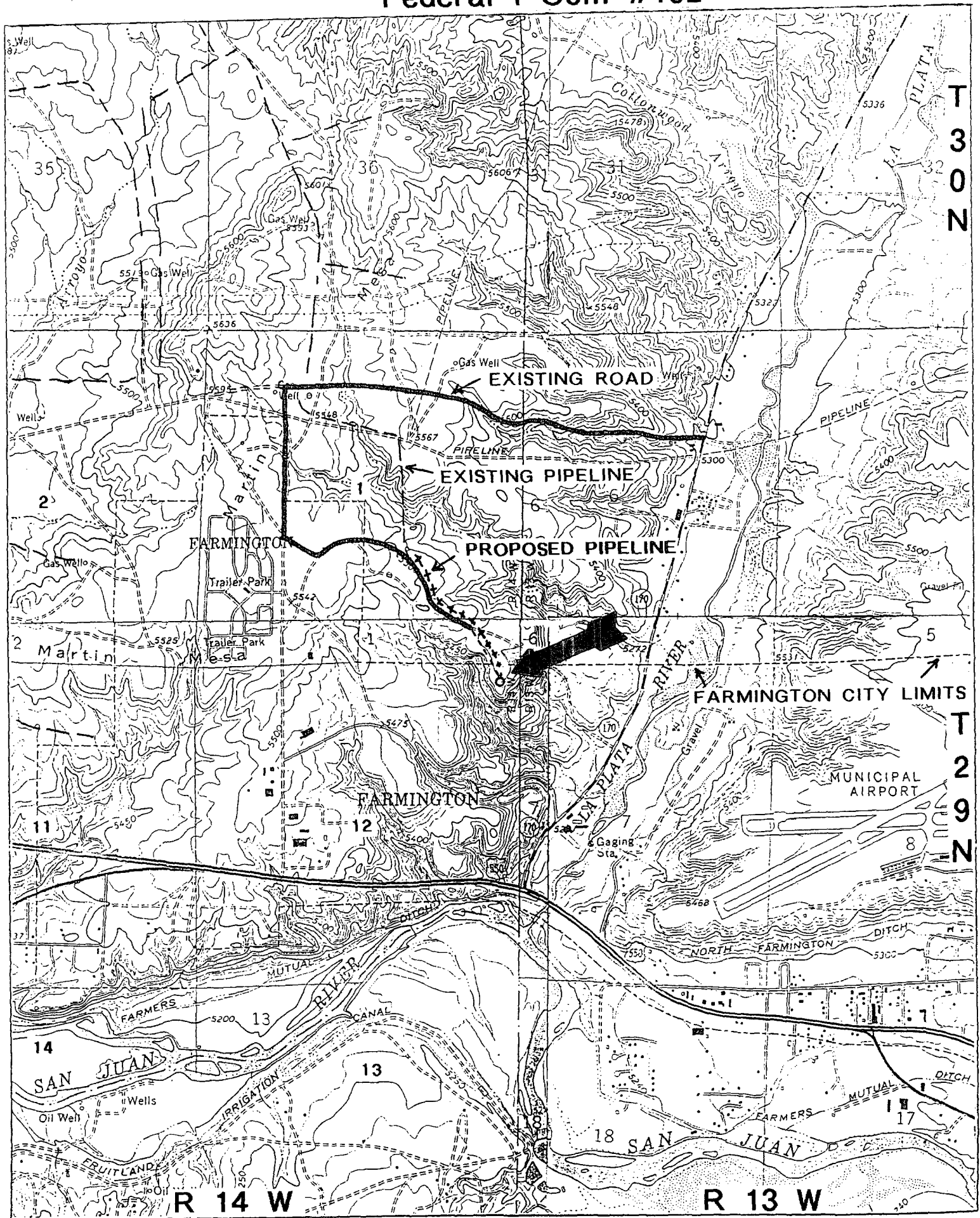

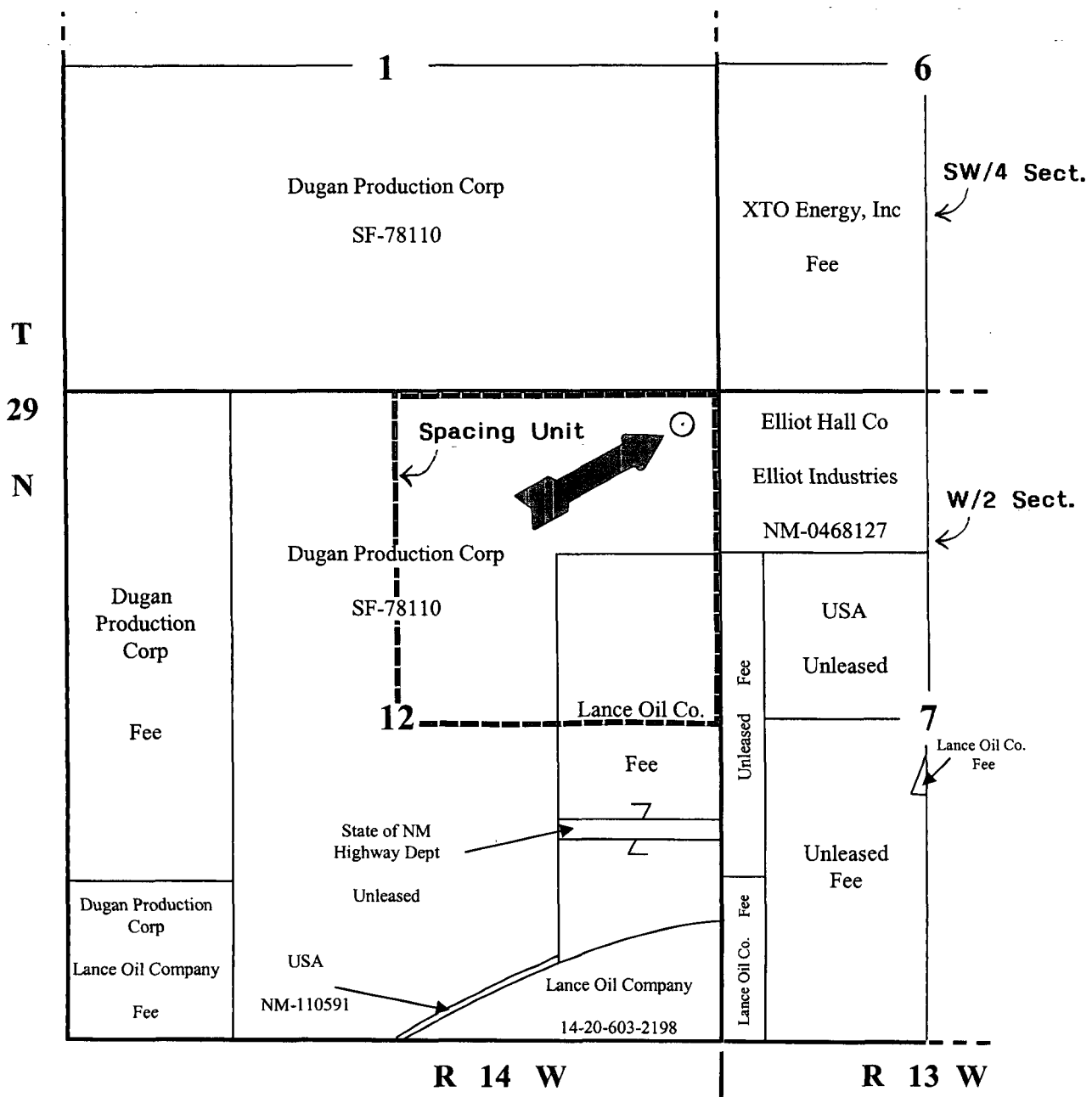
