Gentlemen:

McKay Oil Corporation desires to drill a location 660' from the south line, and 2080' from the east line of unit O in Section 31, of Township 5 South, Range 22 East. Due to geological concerns and in an effort to clear an existing pipeline, McKay Oil is requesting an unorthodox location.

The well was originally staked at 660' from the south line and 1980' from the east line of Section 31. Due to an existing pipeline in which crossed the location the BLM was unable to approve this location or any other normal location within this particular drilling space unit. (See attachment "A" & "B")

The well will be drilled to the ABO formation. The west half of the southeast quarter was chosen due to geological concerns. Further, any location farther to the east would keep the well from clearing the pipeline. The pipeline runs through the northeast quarter of the location. There is also a dry hole located to the east of the location. Any location feasible to drill would have to be a non-standard location. Therefore, it is our opinion that this location would be the best economical and productive location to drill. (See attachment ("C" and "D")

McKay owns the operating rights surrounding the location, with the exception of Section 2, of Township 6 South, Range 22 East, which is controlled by Yates Petroleum Corporation. Enclosed is a copy of a letter from Yates Petroleum, stating that they have no objection with the nonstandard location. (See attachment "E")



McKay Oil Corporation would request and appreciate your immediate attention to this matter. Thank you for your cooperation and assistance.



LOCATION VERIFICATION MAP


