Pursuant to Division Rule 104.F(2), Bass Enterprises Production Co. applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	Poker Lake Unit Well No. 236
<u>Location:</u>	1555 feet FNL & 125 feet FWL
<u>Well unit:</u>	SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 19, Township 24 South, Range 30 East, N.M.P.M., Eddy County, New Mexico

The well will be drilled to a depth sufficient to test the Delaware formation (Nash Draw-Delaware Pool). The pool is spaced on statewide rules, with 40 acre spacing, and wells to be located no closer than 10 feet to a quarter-quarter section line. A Form C-102 for the well is attached as Exhibit A.


The location is based on topographical reasons. The original location was near an existing lease road, and which minimizes surface disturbance. However, that location is also near several pipelines or overhead power lines, so the location was moved to the east. See Exhibit B.

Although geology is not involved in this application, a structure map of the Lower Brushy Canyon (the primary productive zone) is attached as Exhibit C, covering Section 18 to the north. The structure at the proposed location is as good as in the wells to the north.

The well is located on Federal Lease NM 02860, which covers, among other lands, all of Section 19 and offsetting Section 20, and has common ownership. See Exhibit D. Therefore, there is no adversely affected party, and notice has not been given to anyone.

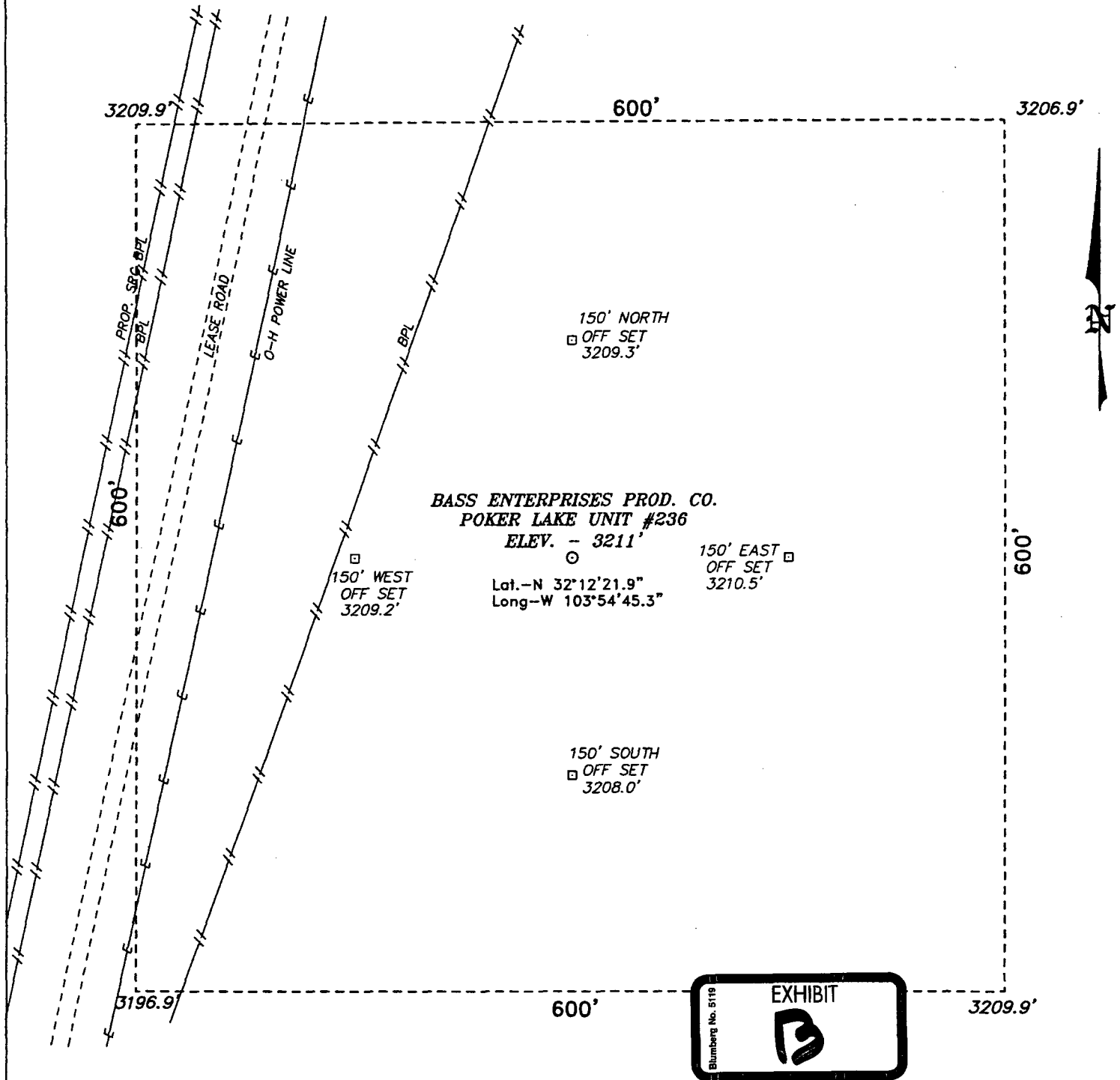

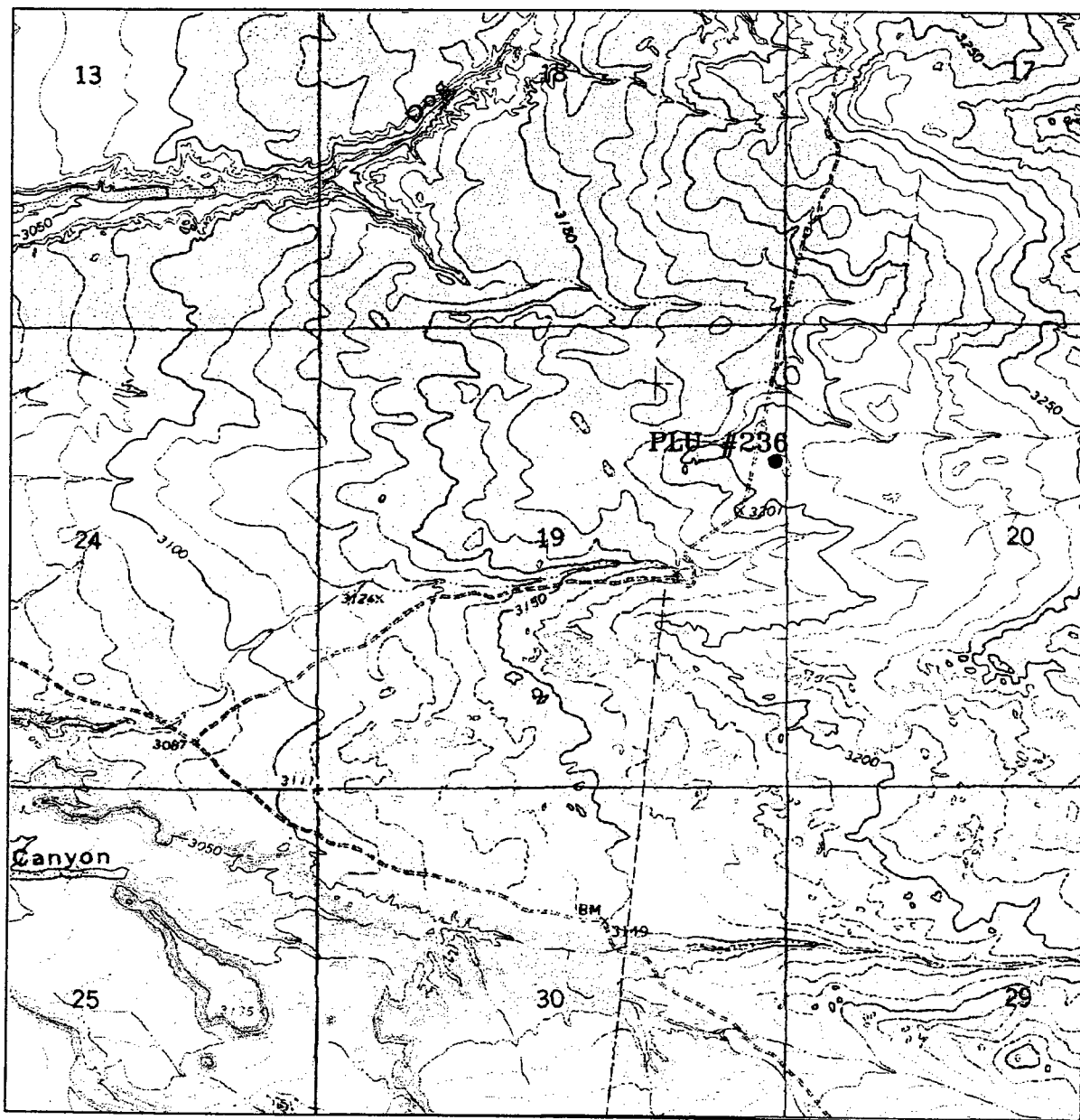

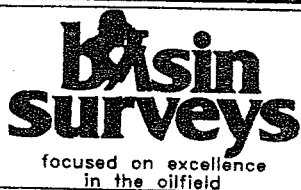
THE POKER LAKE UNIT No. 236 LOCATED 1555' FROM

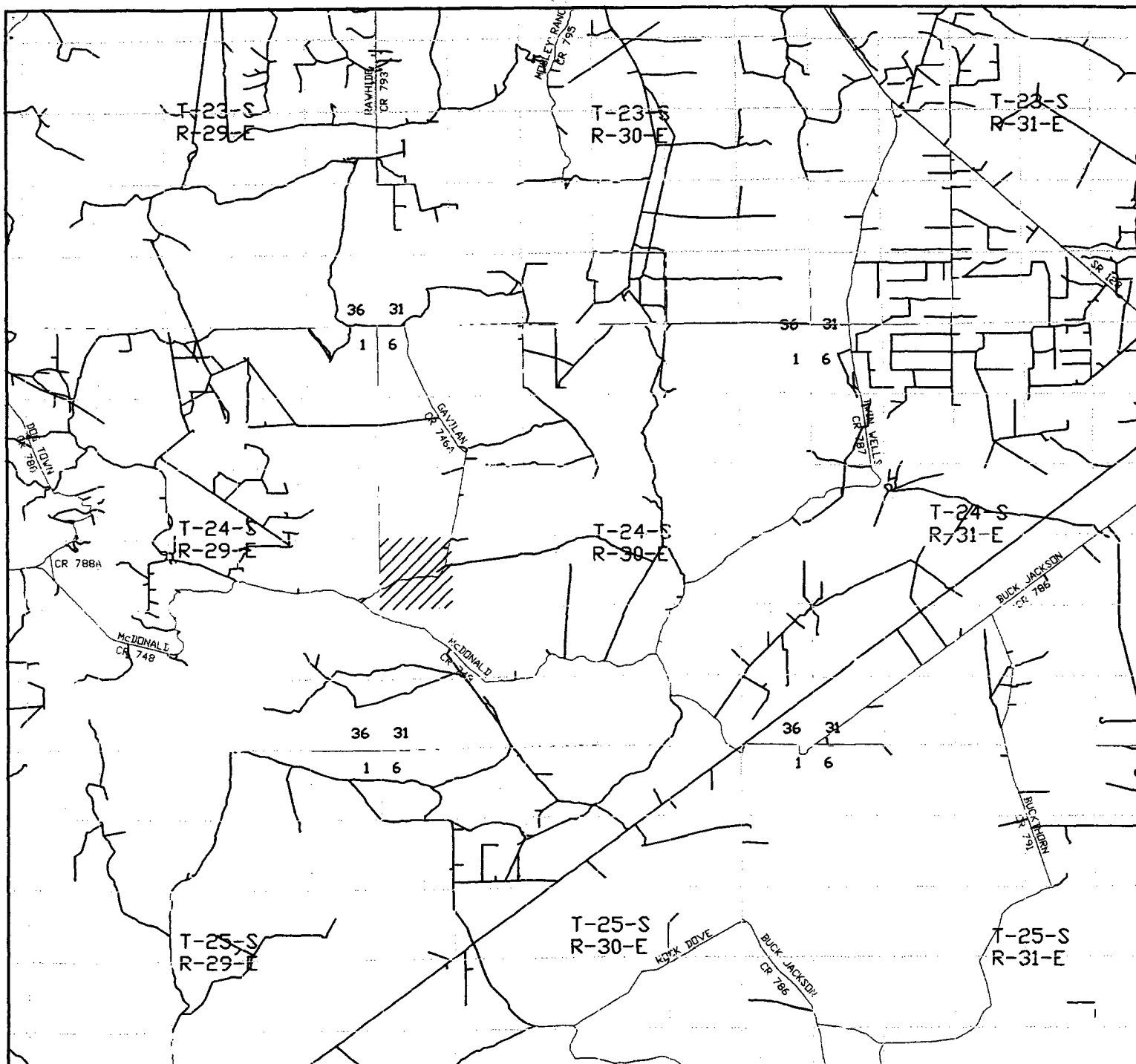
