

Re: Application of Yates Petroleum Corporation for Administrative Approval of an Unorthodox Well Location for its Gato Loco "BFT" Com Well No. 1 located 1800 feet from the South line and 900 feet from the East line of Section 31, Township 8 South, Range 34 East, N.M.P.M., Roosevelt County, New Mexico.

Dear Mr. Fesmire:

Pursuant to the provisions of Division Rule 104 F (2) adopted on January 18, 1996, and Rule 3 of the Special Rules and Regulations for the Vada-Pennsylvanian Pool, adopted on September 12, 1968, by Order No. R-3179-B Yates Petroleum Corporation hereby seeks administrative approval of an unorthodox well location for its Gato Loco "BFT" Com Well No. 1 located 1800 feet from the South line and 900 feet from the East line of Section 31, Township 8 South, Range 34 East, N.M.P.M., Roosevelt County, New Mexico. The SE/4 of Section 31 will be dedicated to the well. The well was originally drilled at a standard gas well location in the Northwest Jenkins-Atoka Gas Pool. See Oil Conservation Division form C-102 attached hereto as Exhibit A. The proposed Gato Loco "BFT" Com. Well No. 1 has been re-completed up hole Pennsylvanian formation. Yates has reviewed this re-completion with Mr. Paul Kautz in the Division's Hobbs District Office who has confirmed that the well is completed in the Vada-Pennsylvanian Pool.

This location is unorthodox because it is governed by the Rule 4 of the Special Rules and Regulations for the Vada-Pennsylvanian Pool which provides for wells on 160-spacing units to be located within 150 feet of the center of a governmental quarter-quarter section or lot. The location is therefore too close to the center of the dedicated 160-acre spacing unit in this pool. Attached hereto as **Exhibit B** is a plat as required by

Rule 104.F (3) showing the subject spacing unit, the proposed unorthodox well location, the offsetting wells and the diagonal and adjoining spacing units. The NW/4 of offsetting Section 32 is now owned by J. Cleo Thompson, not Ard Drilling as shown on the plat.

Rule 5 of these Special Pool Rules and Regulations provide that the Director of the Division may grant an exception to these rules where the unorthodox location has been necessitated by the recompletion of a well previously drilled to another horizon. This rule also provides a that all offset operators shall be notified of the application by registered or certified mail and that the application shall state that such notice has been furnished.

On the date this application was filed, notice was provided to all offsetting operators by providing each with a copy of this application, including the plat attached thereto, by Certified Mail advising each that they have 20 days from the date of the notice letter to file an objection with the Santa Fe Office of the Oil Conservation Division and that, if no objection is received by the Division, the application may be approved.


