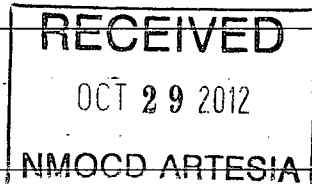

10' x 10' area at leak site. Fluid picked up and soil dug up. Remediation will be turned over to Talon Environmental.
