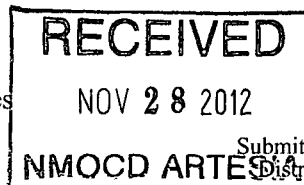

#### Describe Cause of Problem and Remedial Action Taken.\*

Release was from a production tank. Oil hauler rejected load and tank overflowed. Shut off producing well. All oil contained within lined/bermed battery. Vacuum truck called to pick up standing fluid.

#### Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 10' X 50'. All released crude oil contained within lined/bermed battery. Liner intact and all standing fluid recovered with remaining fluid entrained in gravel. Gravel to be removed, disposed at an OCD approved site, and replaced. **Depth to Ground Water: <100' (approximately 85', Section 24-T21S-R31E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on recovered amounts of oil, release within lined/bermed containment area, disposal of impacted gravel at an OCD approved site, Yates Petroleum Corporation requests closure.**
