I. The proposed oil well (see APD as Exhibit A) is on private surface (Bogle Ltd. Company c/o COG) and NM State Land Office oil and gas lease X006470405 (8,746.59 acres). The well is 1,120' from the closest lease line (Exhibit B). The proposed oil well is nonstandard for the Artesia; Glorieta-Yeso (Pool 96830) due to a steep $\approx 50'$ high slope (Exhibit C).

Apache requests a nonstandard location due to land uses. The well was planned to be staked 2310 FNL & 990 FWL. However, a steep $\approx 50'$ high slope prevented that location. *to go*

A standard location must be at least 330' from the quarter-quarter line. The well bore is 200' from the east quarter-quarter line (see C-102 as EXHIBIT D). It is 130' too far east. It is 330' from the south side of the quarter-quarter and 385' from the southeast corner of the quarter-quarter.

II. Form C-102 showing the well and 40 acre pro ration unit (SWNW Section 26) is attached as Exhibit D.

Exhibit E shows the existing Yeso acreage dedications (dashed lines). There are no existing Yeso dedications in NESE Section 27. The well encroaches 130' too far east toward the SENW Section 26. The encroachment is part of the same state lease.

Apache operates all Yeso wells in the S2NW4 & N2SW4 Section 26. Apache and its partners have 100% of the Yeso working interest in the affected offset quarter-quarters. Closest Yeso well is Apache's D State 58 (30-015-38588), which is 490' southwest at 2400 FSL & 1140 FWL 26-17s-28e.

III. The state oil and gas lease boundary is shown on EXHIBIT B. The well encroaches to the east. The encroachment is part of the same lease. Seven existing Yeso pro ration units (see Exhibit E) touch the proposed pro ration unit. Five of the seven are Apache operated. Apache and its partners have 100% of

the Yeso working interest in the quarter-quarter in which the well is located, the quarter-quarter (SENE Section 26) toward which the well encroaches, and the closest cornering quarter-quarters (N2SW4 Section 26). This information is current and correct.

IV. Exhibit F shows the proposed well, proration unit, and all wells. Yeso wells are circled. Apache does not believe directional drilling to a standard location from an existing pad is cost effective for this well.

V. A steep $\approx 50'$ high slope prevents a standard location.

VI. Archaeology is not an issue.

VII. The well was planned to be staked 2310 FNL & 990 FWL. However, a steep $\approx 50'$ high slope prevents a standard location.

VIII. Apache does not believe directional drilling to a standard location is cost effective for this well.

IX. I hereby certify that Apache Corporation and its partners have 100% of the Yeso working interest in the lease which comprises the proposed 40 acre spacing unit and the adjacent quarter-quarters (SENE & N2SW4 Section 26) on one or more of the two sides or the single closest corner to the proposed well toward which it encroaches and that the information is current and correct.

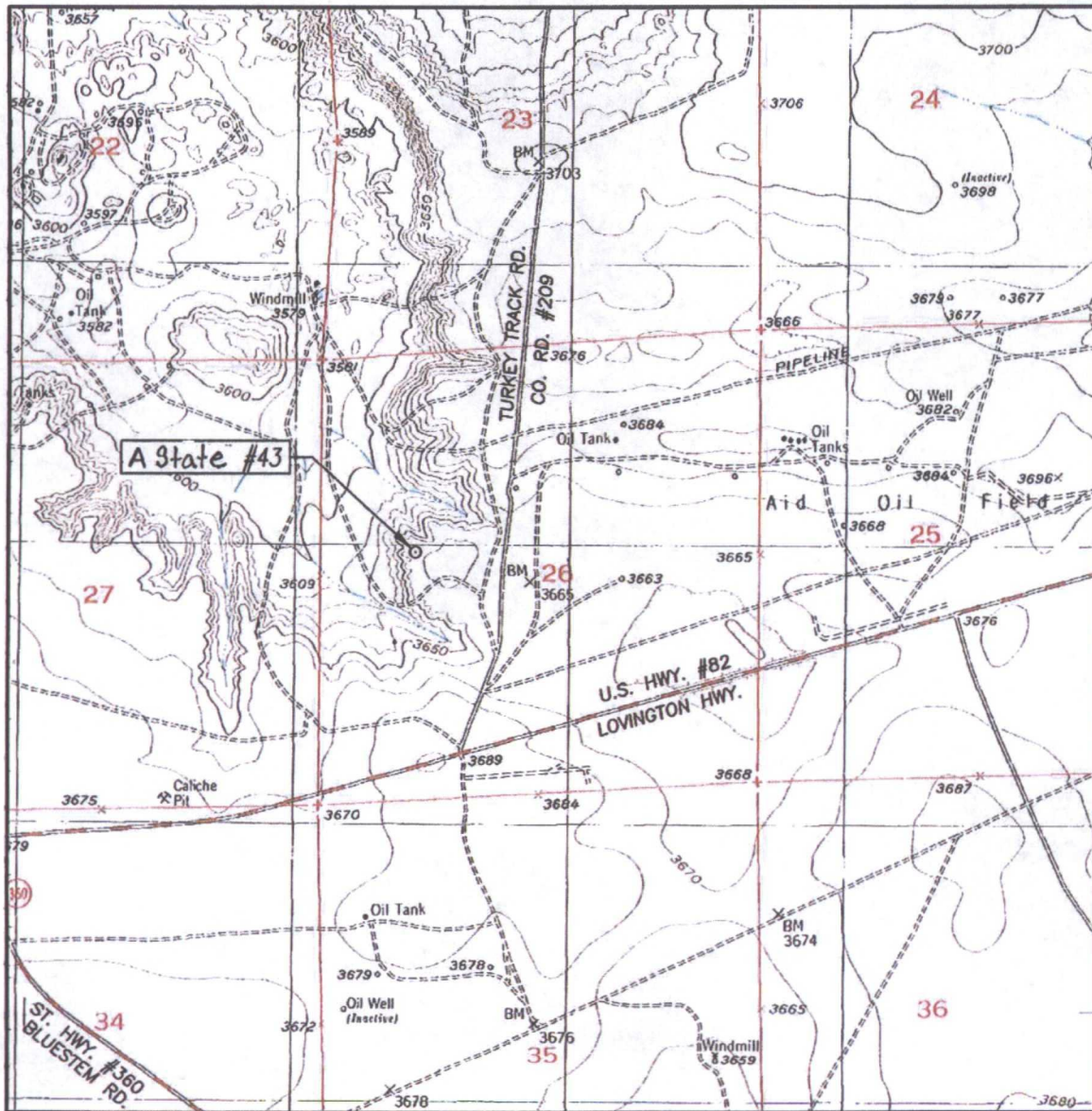
