The inlet header at the facility malfunctioned allowing the release of fluid. The header is located on the backside of the facility. The header has been repaired.

Describe Area Affected and Cleanup Action Taken.*

Initially 320bbbls were release from the inlet header and we were able to recover 280bbbls with a vacuum truck. The spill area is located on the backside of the facility. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
