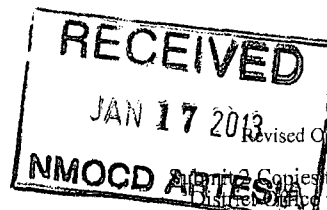

This is to inform you that Oxy Permian Primary had a spill of produced water at the Old Ranch Knoll 8-6 on January 15, 2013. Oxy released 100 bbls of produced water, 70 bbls was recovered. Leak was due to a 3 INCH STEEL WATER LINE FROM DISCHARGE SIDE OF 3 PHASE SEPARATOR, THE WELL IS GOING TO BE PLUGGED. Oxy will have BBC do some initial remediation, a C-141 to follow. BBC will delineate at a later date.
