The Farmington District Office (FDO) of the Bureau of Land Management (BLM) has received your letter dated February 12, 1996, for downhole commingling of the Blanco Mesaverde and Aztec Pictured Cliffs Pools in the above referenced well.

Your application stated that historical data will be used in determining the allocation percentage for each formation. Presently, the Mesaverde formation is producing 32 MCFD and 0.03 BCPD and the Pictured Cliffs is producing 2 MCFD and > 0 BCPD. Corrected bottom hole pressures are 482 psi for the Pictured Cliffs and 464 psi for the Mesaverde. Using these values, the fixed percentage for allocated production for each formation has been determined as follows:
