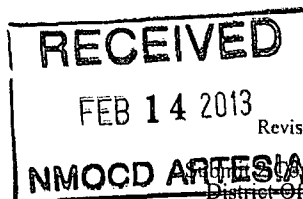

A hole developed in the water dump valve at the FWKO. The old valve has been replaced with a new valve.

Initially 18bbls were released from the water dump valve at the FWKO and we were able to recover 15bbls with a vacuum truck. The entire release was contained inside the lined facility at the Myox 21 State Com #9H Tank Battery. All free fluids have been recovered. Any contaminated gravel has been removed, the liner has been washed, and we have replaced with clean gravel as necessary. This facility has been returned to its prior condition.
