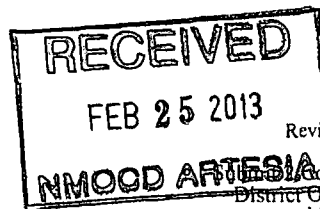

Describe Cause of Problem and Remedial Action Taken.*

A Durco pump discharge 3X2 swage cracked when the pump kicked on. Replaced with new plastic coated parts.

Describe Area Affected and Cleanup Action Taken.*

Initially 20bbls of produced fluid were released into the lined facility. We were able to recover 15bbls of fluid with a vacuum truck. The majority of the release remained inside the facility. All free fluid has been recovered. We removed the contaminated gravel from the facility and replaced it with new gravel. The facility has been returned to its prior condition. Tetra Tech will sample the spill area outside the SWD to delineate any possible contamination from the release and we will present a work plan to the NMOCD for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
