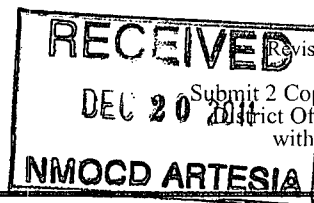

A small hole developed in the flow line. Upon discovery of leak, well was shut in and flow line was isolated.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 20' X 20'. Vacuum truck called to pick up remaining oil, impacted soils to be scraped up and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted. **Depth to Ground Water: >100' (approximately 130', Section 21-T19S-R25E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on site ranking of "0", and impacted soils excavated/hailed and enclosed analytical results Yates Petroleum Corporation requests closure.**
