It is our understanding that these 8 wells consist of two groups, between which ownership is not identical; but ownership within each group is identical. The operator shall continuously meter Administrative Order PLC-368 COG Operating LLC March 1, 2013 Page 2 of 3

oil and gas production for each identically owned group of wells prior to commingling for sales. Within each identically owned group of wells, periodic well testing is approved for allocation of production and sales.

It is our understanding that proper notice has been provided in this application and no protest has been received.

The location for oil and gas sales shall be as stated in the application, within Unit letter H of Section 10.

As allowed in 19.15.12.10 NMAC, this application for surface commingling, on the terms outlined above, is hereby approved.

The operator shall notify all transporters of this commingling authority and the District office of the Division upon commencement of any off-lease measurement and sales. This approval is subject to like approval from the U.S. Bureau of Land Management.
