ADMINISTRATIVE POOL/LEASE COMMINGLING ORDER

Pursuant to your application received on March 22, 2013, BOPCO, L.P. (OGRID 260737) is hereby authorized to surface commingle oil and gas production from wells, one of which has diverse ownership, ("the subject wells") specifically identified on Exhibit A hereto, located in Section 3, 4, 9, 10 and 11 Township 24 South, Range 30 East, NMPM, Eddy County, New Mexico.

The subject wells are all located on the Poker Lake Unit except for the PLU Remuda Basin 4 24 30 Well No. 1H ("Remuda Basin Well") which is located on a different lease. Each of the subject wells produces from a distinct pool, as specifically described on Exhibit A. Each well produces from only one pool. No downhole commingling is involved.

Production from each well shall be separately measured by a check meter prior to commingling. All meters shall be calibrated in accordance with Rule 19.15.26.12.10.C(2). Oil production from the Remuda Basin Well will be routed to a separate tank battery and not commingled.

The commingled oil and gas production shall be sold at the central tank battery and gas delivery point located in the Unit K of Section 4.

The operator shall notify the transporter of this commingling authority.


The operator shall notify the Artesia District Office of the Division upon commencement of commingling operations.
