BP America respectfully requests administrative approval for a non-standard location for the above referenced well. Attached for your reference are the following exhibits:



The subject well was drilled and completed on August 6, 1985 in the Basin Dakota on a 320 acre unit. BP America would like to re-complete the subject well in the Totah Gallup formation, which is within the Totah Gallup Oil Pool on an 80 acre stand up unit, and downhole commingle with the existing Basin Dakota. The Dakota (71599) & the Totah Gallup (59750) pools are pre-approved for DHC per NMOCD Case No. 12520; Order No. R-11567 effective 04/26/2001. Although the interest owners are not identical between these two pools, this same order established approval for subsequent applications for DHC of production in wellbores within the GCU without notice to the unit interest owners. BP America received DHC approval 03/05/2013 by order DHC 3773 AZ.

The rules state that the well should be located within 150 feet of the center of the quarter-quarter section in the 80 acre unit of the Totah Gallup Oil Pool. The existing location will not conform to the required footages. A new well would not be economically feasible to drill for just the Totah Gallup formation. The current wellbore is in acceptable condition for the recompletion attempt with no additional work being required. By moving up the hole to the Totah Gallup formation, BP America would be able to minimize environmental impact in obtaining additional production and protection of correlative rights.

BP America, Burlington Resources Oil & Gas Co. LP, Energen Resources and Las Colinas Minerals are offset operators in the Gallegos Canyon Unit, therefore notification of the non-standard location application is required and has been sent by certified mail to Burlington Resources, Energen Resources and Las Colinas Minerals. 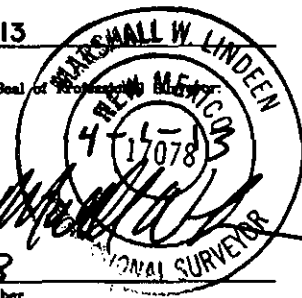

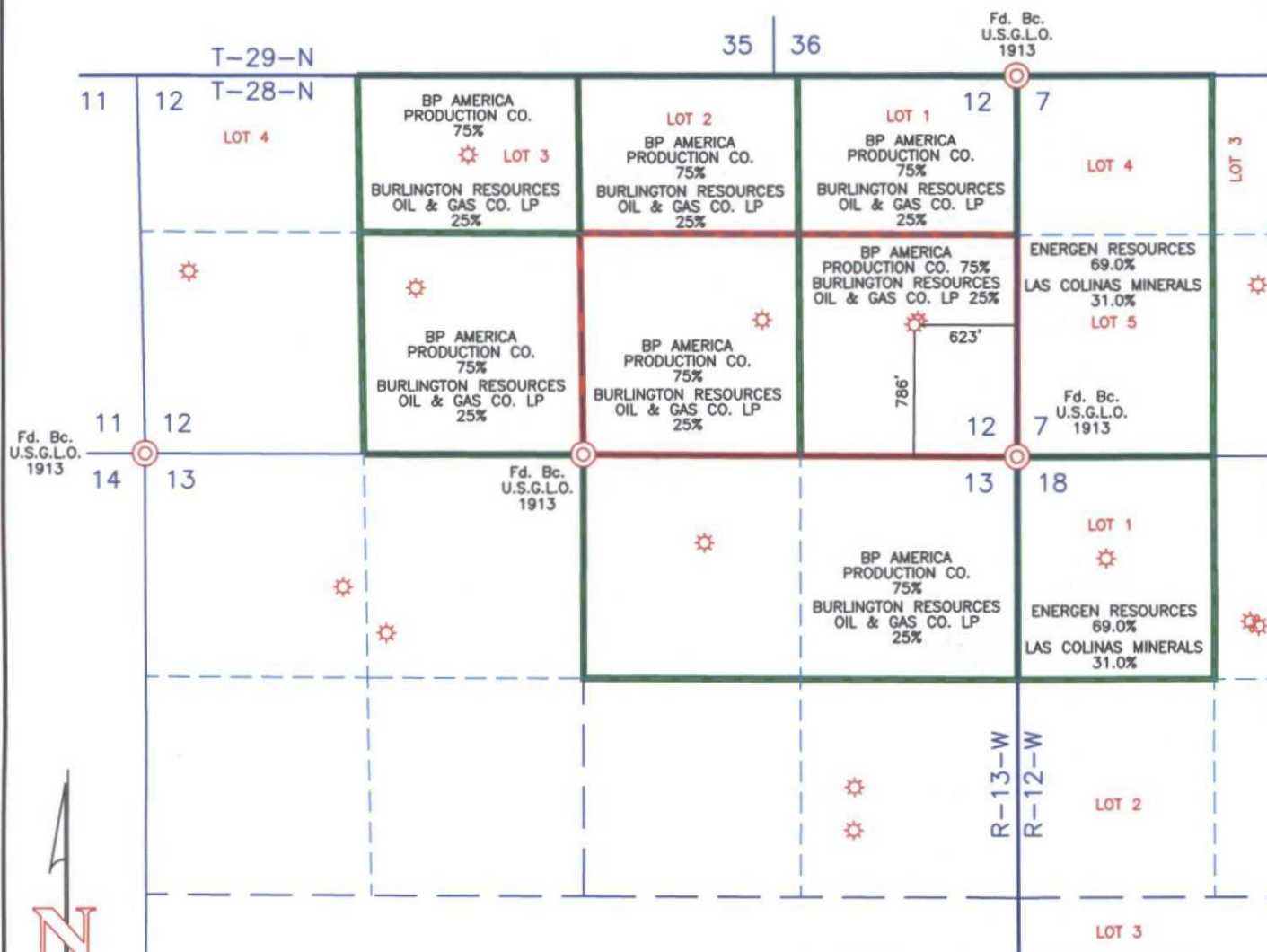
