Rice Operating Company (ROC) is the service provider (agent) for the EME Saltwater Disposal (SWD) System and has no ownership of any portion of the pipeline, well, or facility. The System is owned by a consortium of oil producers, System Parties, who provide all operating capital on a percentage ownership/usage basis.

Background

In 2001, ROC initiated work on the former I-1-A and I-1-C junction boxes. The site is located in UL/I, Sec. 1, T20S, R36E. NM OSE records indicate that groundwater would likely be encountered at a depth of approximately 26 +/- feet. To investigate the depth of chloride presence, a soil bore was installed on November 14, 2001 to a total depth of 25 ft below ground surface (bgs). Samples were collected every 5 ft and field titrated for chlorides, resulting in low concentrations. The 15 ft sample was sent to a commercial laboratory for analysis, resulting in a chloride concentration of 62 mg/kg, a DRO concentration of 22 mg/kg, and GRO and BTEX concentrations below detectable limits.

The site was delineated using a backhoe to collect soil samples at regular intervals, creating a 42x30x8.5 ft deep excavation. Each sample was field titrated for chlorides, resulting in slightly elevated concentrations. Representative samples were collected from the excavation walls and excavation bottom and sent to a commercial laboratory for analysis. The sidewall sample resulted in a chloride concentration of 128 mg/kg, a gasoline range organics (GRO) concentration below detectable limits and a diesel range organics (DRO) concentration of 404 mg/kg. The bottom composite sample resulted in a chloride concentration of 656 mg/kg, a GRO concentration below detectable limits and a

DRO concentration of 220 mg/kg. Both samples were also analyzed for BTEX resulting in a sidewall benzene concentration below detetable limits, 0.014 mg/kg for toluene, 0.012 mg/kg for ethyl benzene and 0.19 mg/kg for total xylenes. The bottom concentration of benzene was below detectable limits, a toluene concentration of 0.015 mg/kg, an ethyl benzene concentration of 0.017 mg/kg, and a total xylenes concentration of 0.19 mg/kg.

A total of 396 cubic yards of excavated soil was properly disposed of at a NMOCD facility. A compacted clay liner was installed and the excavation was backfilled with clean imported soil to ground surface and contoured to the surrounding area. A new, watertight junction was installed.

The junction box site location map, final report, laboratory analysis, soil bore log, disposal manifests and current photodocumentation are attached.

Recommendations

Site investigation demonstrates that residual chloride and hydrocarbons in the vadose zone will not with reasonable probability contaminate groundwater in excess of NMOCD standards. This site meets the requirements of the NMOCD-approved Revised Junction Box Upgrade Work Plan (July 16, 2003). As such, ROC request termination of the regulatory file, or similar closure status.






