Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed A State No. 67. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830) at an unorthodox oil well location 1790 feet from the North line and 2340 feet from the West line (Unit F) of Section 26, Township 17 South, Range 28 East, NMPM, Eddy County, New Mexico.

The proposed A State No. 67 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the SE/4 NW/4 of Section 26. This unit is currently dedicated to Apache's: i) existing A State No. 51 (30-015-38582) located at a standard well location 1700 feet from the North line and 1835 feet from the West line; ii) proposed A State No. 66 (API No. 30-015-41126) located at a standard well location 2260 feet from the North line and 1750 feet from the West line; and iii) proposed A State No. 68 (API No. 30-015-41128) located at a standard well location 2310 feet from the North and West lines.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The proposed unorthodox location is necessary in order to avoid an existing well pad and paved road.

The affected offset acreage is the SW/4 NE/4 of Section 26, Township 17 South, Range 28 East. This affected tract is an existing 40-acre spacing unit in the Artesia Glorieta-Yeso Pool that is operated by Apache. Please note that the working interest ownership between the SE/4 NW/4 of Section 26 and the affected offset 40-acre tract is common. Consequently, notice of this application is not required to any party.

Attached is a Form C-102 showing the proposed well, other existing and/or proposed wells in the spacing unit and the affected offset acreage.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the SE/4 NW/4 of Section 26 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.
