Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed A State No. 77. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed A State No. 77 will be dedicated to an existing spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the NE/4 SW/4 of Section 26. This unit is currently dedicated to Apache's: i) existing A State No. 42 (API No. 30-015-38578) located at an unorthodox well location 2310 feet from the South line and 2430 feet from the West line; ii) proposed A State No. 76 (API No. 30-015-41130) located at an unorthodox well location 1550 feet from the South line and 1575 feet from the West line; and iii) proposed A State No. 75 (API No. 30-015-41180) located at a standard well location 2310 feet from the South line and 1650 feet from the West line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The proposed unorthodox well location is necessary in order to avoid existing pipelines and electric lines within the drill tract.

The affected offset tracts are the NW/4 SE/4, SW/4 SE/4 and SE/4 SW/4 of Section 26, Township 17 South, Range 28 East, NMPM. The NW/4 SE/4 of Section 26 is currently being developed in the Artesia Glorieta-Yeso Pool by numerous wells

operated by Apache. Please note that the working interest ownership between this affected offset tract and the drill tract is common. The SE/4 SW/4 and the SW/4 SE/4 of Section 26 are also being developed in the Artesia Glorieta-Yeso Pool by numerous wells operated by Apache. Please note that the working interest ownership between these two affected offset tracts and the drill tract is not common. Consequently, Apache is providing notice of this application to all working interest owners within the SW/4 SE/4 and SE/4 SW/4 of Section 26 in accordance with Division rules. These parties are shown on the notice list attached to this application.

Attached is a Form C-102 showing the proposed well, spacing unit, other existing and proposed wells in the spacing unit, and the affected offset acreage. Also attached is a vicinity map, notice list and notice letter.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the NE/4 SW/4 of Section 26 that may otherwise not be recovered by the existing or proposed wells, thereby preventing waste, and will not violate correlative rights.
