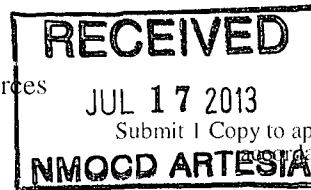

Upon discovery, the well was shut in and the flow line repaired. Met with Jim Amos on the spill site and discussed issues of compliance and remedial work to be performed. Hungry Horse, LLC will conduct the remediation and submit closing documents.
