Apache Corporation ("Apache") hereby requests your approval to surface commingle production from the ten (10) wells listed on Page 2 of this letter and further requests your approval to allocate production from said wells using monthly well tests. Apache further requests your approval to surface commingle production from any future wells drilled by Apache, or its successors and assigns, which are located on the above referenced lands, and allocate production to each well using monthly well tests. *[Handwritten mark]*

Please be aware that the interest ownership for the Bertha Barber Well Nos. 4, 8 and 11 differs slightly from the ownership for the Bertha Barber Well Nos. 13, 14, 15, 17, 18, 22, 23 and any future new drill wells and, therefore, in order to commingle production from each well at the surface and account for each well's production in the manner proposed above, Apache must first obtain approval from the affected interest owners. *[Handwritten mark]*

Apache believes that commingling will not decrease the value of production from each well. Additionally, Apache believes commingling will prevent waste and promote conservation by utilizing the same tank battery equipment for each well, thereby reducing the incremental investment capital that would otherwise be needed to build a separate facility or separately meter each well and, as a result, will extend the economic life of the wells and leases.


