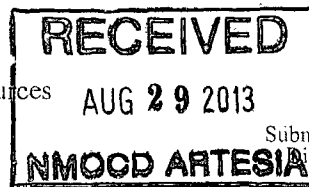

Faulty packing on stuffing box caused release. The well was shut in, packing replaced, vacuum truck and crew to scrap up impacted soils was called to the location. Light mist of oil over-sprayed pasture area NW of location, misted area has been Micro Blazed.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 150' X 50'. Impacted soils scraped up/hailed and area Micro Blazed. Depth to Ground Water: >100' (approximately 175', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on remedial/clean up actions, Yates Petroleum Corporation requests closure.
