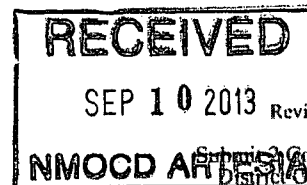



Describe Cause of Problem and Remedial Action Taken.*

Fire tube gasket failed due to high LP pressure. Replace gasket on fire tube.

Describe Area Affected and Cleanup Action Taken.*

Initially 30bbls of oil were released due to a gasket failure on heater treater. We were able to recover 20bbls with a vacuum truck. All free fluid has been recovered. Contaminated gravel has been removed and we have replaced with fresh gravel as necessary. This location has been returned to its prior condition.

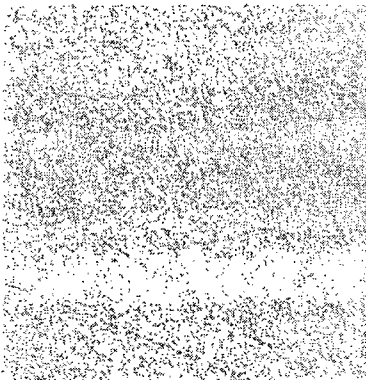
