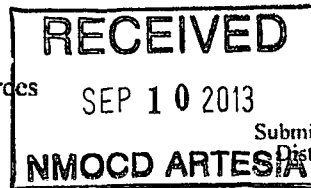

Describe Cause of Problem and Remedial Action Taken.* A 1/4 inch hole developed in a 4" metal line. Replaced the 4" metal line with a plastic coated metal line.					
Describe Area Affected and Cleanup Action Taken.* Initially 20bbls of produced water were released due to a 1/4 inch hole developed by corrosion. We were able to recover 15bbls of produced water with a vacuum truck. The entire release was contained inside the lined facility. All free fluid has been recovered. Contaminated gravel has been removed and we have replaced with fresh gravel as necessary. This location has been returned to its prior condition.
